

## JUNIOR PLAYER REGISTRATION INFORMATION

### **Junior Players:**

NOTE: All junior players must complete a **medical history and release form** and give it to your club director. This form can be printed from the confirmation page of online registration or can be obtained from the FORMS section on the Sun Country website or from your club director. The completed form must be submitted to your club director before you participate in any practices. DO NOT SEND the medical history and release form to the Sun Country office.

1) Go to the appropriate Online Registration link below.

If you use this option, the email address and birthday of the member must be entered. When retrieving your log-in information, the email address you type in must match the email address entered in the account last year. If the email address in that account has changed or your club director registered you last year, contact the club director of the club you were a member of last year. If you are still unable to get your information, notify your club director.

**If you attempt to use an incorrect password more than twice, the account will be locked. REMEMBER, PASSWORDS ARE CASE-SENSITIVE.**

2) Returning members, once you have logged into your account , click on the

**Online** button on the left side of the screen or on the top of the page where it says "To

apply for your membership online, click here."

3) Check your information for accuracy and make changes as necessary as you progress through the process, including the current email, school grade, club choice, etc.

4) PLEASE DOUBLE CHECK YOUR INFORMATION BEFORE SUBMITTING IT, ESPECIALLY YOUR CLUB CHOICE. THE DROP DOWN MENUS ARE VERY SENSITIVE.

## 5) ELECTRONIC WAIVER ACCEPTANCE (applies to all types of memberships)

The electronic waiver acceptance process is now in place for members using online registration. To verify identification of the individual legally accepting the terms of the membership, a driver's license or state identification number must be entered.

When you reach the Electronic Waiver portion of online registration, please refer to the following instructions:

Please note that ALL individuals are required to do the following during registration to satisfy the electronic acceptance requirements:

1. Open the link to the USAV Waiver & Release of Liability;
2. Check the box to agree to the USAV Waiver & Release of Liability;
3. Open the link to the USAV Participant Code of Conduct;
4. Check the box to agree to the USAV Participant Code of Conduct;
5. Check the box to agree to the Use Agreement; and
6. Enter a driver's license or state identification number.

For junior members, the following additional requirements are in place:

1. A Parent/Guardian first name is required;
2. A Parent/Guardian last name is required;
3. A Parent/Guardian email address is required (the confirmation emails are copied to this email address);
4. Additional text is displayed that **the person agreeing to the Waiver & Release of Liability has legal capacity and authority to act for and on behalf of the minor.**

6. After completing the application, choose SUBMIT at the bottom of the page.

7. Print the application confirmation. It would be a good idea to print two copies and keep one on file for your records.

8. Give the **FIRST PAGE ONLY** to your club director. The Waiver and Code of Conduct is to be retained by the member or their parent or guardian. **The only paper document required from individual registrants is this ONE PAGE which has the applicant's name, club and login information. Do not send the Waiver and Code of Conduct documents.**
